INTRODUCTION



ABOUT THIS GUIDE

The information contained in this document relates to the booking of the remote CPD Revalidation exam which is a part of the new requirements for DPO's whose certificates are due to be revalidated from 1st January 2024 onwards.

In order to ease the process of completing the CPD Revalidation Exam, we have added the facility to book it directly from the Home page of your NI Alexis Platform account.

You will be able to pay for and book the date for the exam without having to start your revalidation application.

Please note that this guide is only for booking the Revalidation exam. Please refer to the Revalidation Online Application Guide on how to complete, submit and pay for your application.

LOGGING INTO YOUR ACCOUNT



1 DP LOGIN

Go to the NI Alexis Platform website: http://www.nialexisplatform.org and click on **DP Login** to access the account login screen for the DP online application system.

2 DP INFORMATION CENTRE

The revalidation requirements, guides, FAQs and downloadable forms, etc, can be found in the Offshore DP Revalidation section.

3 DON'T KNOW YOUR LOGIN DETAILS?

Use the 'Forgot Password' option to be sent a temporary password to the email address registered on your account.

The registered email address may be different to the one you are currently using, so check any other email accounts too.

If the system does not recognise your email address try using **Revalidating but don't know your login details?** This option only works on accounts where no email address is registered. A temporary password will then be set up on your account and be sent to you via email.

If you cannot find the email with the temporary password, please check the spam/junk folders and try searching the mailbox for emails from 'Nautical Institute'.

The temporary password will only be active until midnight the following day, so make sure that you log into your account and update your password as soon as the email arrives. If you do not change the password in time, you can use the 'Forgot Password' option again to have another temporary password sent to you.

4 CREATE NEW ACCOUNT


As you are revalidating you already hold an account with us. **DO NOT CREATE A NEW ACCOUNT** as this will cause a delay in you being able to apply.

1 BOOKING THE ONLINE EXAM

Once you have logged in to your account you will see the option to book the Online Revalidation Exam.

2 PAYING FOR THE EXAM

Once you have clicked the button to book the exam, you will be taken to the payment page where you will need to confirm that you wish to book the exam and that you agree to the Terms and Conditions.

3 PROCEED TO CHECKOUT

After you have selected 'Proceed to checkout', you will complete the payment for the exam.

Please note that you need to use the same account that you used for your previous TestReach online exams. If you cannot remember your password, you have the option to reset this once you have downloaded the program and are asked to login.

Taking an exam on this platform is very straight-forward and if you haven't already done so, you should carry out the following steps:

- Click on this link to download the TestReach Application onto the laptop or computer that you plan to use for your exam: https://app.testreach.com/system-requirements
- Launch the application on your computer and login
- Complete the system check and confirm your exam booking.
- Take the Test Tutorial this lets you explore the in-exam environment and is strongly recommended to ensure you are fully prepared to take your exam

LOGGING IN TO TESTREACH

1 Once the payment for your exam has been completed you will receive an email from The NI confirming that the payment has been received.

2 CHOOSING THE EXAM DATE

Once the payment has been completed you will need to check that you have received the email from customersupport@testreach.com with instructions on how to login to your TestReach account. Once logged in, you will be able to select the day and time (UTC) for your exam.

LOGGING IN TO TESTREACH



1 TESTREACH LOGIN


Once the TestReach programme has been downloaded, you will need to login using the same email address that you used for sitting your previous exams. If you do not know your password, you will need to use the 'forgotten password' option.

2 RESET PASSWORD

When prompted, you should enter your email address and click on the 'Send verification Email' button.

You will then need to check your inbox for the email to reset your password.

SETTING UP FOR THE EXAM



1 GET STARTED

Once you have logged in to TestReach you will be taken through the steps to being able to successfully complete your online exam.

2 BOOKING YOUR EXAM

After you have clicked on the 'Get started' button you will be taken to the next page where you will have the options to check set-up, take the tutorial and to book the date and time for the exam,


3 SELECTING THE DATE & TIME FOR YOUR EXAM

After you have checked the set-up, you will be able to choose the date and time of your exam by clicking on the calendar.

- Choose a date that is at least five days in the future.
- Confirm your choice of the day and time of the exam, and then logout of your account.
- At least 72 hours before the date of your exam, log in to your TestReach account and confirm that you will be attending.

4 TUTORIAL

You should complete the tutorial at least once to ensure that you are happy with how to navigate your way through completing the exam successfully.




1 COMPLETING THE ONLINE EXAM


When the exam date arrives you should sign in to your TestReach account at least 30 minutes before the exam is due to begin and connect to the supervisor who will be invigilating your exam.

AFTER COMPLETING THE EXAM

1 EXAM COMPLETED

After you have completed the online exam, please ensure that you **print the PDF report** of your exam results before you log out of the TestReach programme, as you **will not** be able to access this later.

Whether you have passed or failed the online exam, your results will automatically be updated in your online account.

2 EXAM FAILED

If you have failed the exam, you will need to contact The Nautical Institute at testreach@nautinst.org to be allocated to your next attempt. You will then be able to login to the TestReach app to book the date and time.

3 EXAM PASSED

If you have passed the exam and also completed the other CPD requirements to revalidate your certificate, you should log into your account and complete your online application if you have not yet done this. Please click here for the Revalidation Application Guide.

If you chose the option at checkout that says you have completed the new requirements, once the payment has been made, your application status will show as Submitted/Paid, and will be added to the queue to be processed.

If you have already submitted and paid for your application and chose the option at the checkout that says you have not yet completed all the new requirements, you should now log into your account and resubmit your application. Your application will then be placed into the queue to be reprocessed.

Note: If your CPD is still to be completed, you should not resubmit your application until all the requirements have been met.

IMPORTANT INFORMATION

The exam is composed of 30 multiple-choice questions (written in English), and shall be completed in one hour with a pass mark of 70%.
